3. Preparation of Bids

The bids shall be made through the prescribed Bid form which the Bidder shall complete, sign and date in the spaces provided for that purpose.

4. Submission of Bids

Bidders shall submit the following documents enclosed in a sealed envelope:-

5. <u>Late Bid Submission</u>

Bids received after the prescribed time and date shall not be considered.

6. Bid Bond

Bids should be accompanied by a Banker's Cheque representing 10% of the quoted price, from a commercial bank drawn in favour of the District Council of Riviere du Rempart. Please note that personal/company's cheque will not be accepted.

The banker's cheque will be realized and enforced immediately upon acceptance of the offer by the Council and the amount thereof will be forfeited if the purchase is not finalised within ten (10) days of acceptance. The cheques accompanying offers which are not accepted will be returned to the unsuccessful tenderer(s).

7. Validity of Bid

The bid submitted shall be valid for a period of 90 days.

8. Inspection
