EXPRESSION OF INTEREST

OCCUPATION OF VACANT STALLS FOR GENERAL MERCHANDISE SECTION & VEGETABLES SECTION AT NEW GOODLANDS MARKET

In accordance with Section 57(1)(a) of the Local Government Act 2011, the District Council of Riviere du Rempart hereby invites Expressions of Interest for the Occupation of stalls at the General Merchandise Section and Vegetables Section of New Goodlands Market.

Application forms are available at the Registry of the Public Health Department of the Council during working hours from 9.30hrs to 15.30hrs. Those interested are kindly requested to fill in the form and submit together with copies of the following documents:

- 1) National Identity Card
- 2) Birth Certificate issued less than three (3) months from date of application.
- 3) Marriage Certificate (if applicable) issued less than three (3) months from date of application.
- 4) Proof of address (CEB, CWA, Telephone Bill, Bank Statement- Less than 3 months), Postal Code or such other document as may be accepted by the Council).
- 5) Unemployment card from the Ministry of Labour and Industrial Relations.

Priority of consideration will be given to inhabitants of District Council of Riviere du Rempart area and those who are unemployed.

N.B Those who have already submitted a written request should also fill in the required form mentioned above.

Application forms (bearing the seal of the District Council of Riviere du Rempart) duly filled and signed together with the relevant documents should be submitted in plain envelope and address to the Chief Executive, The District Council of Riviere du Rempart and deposited in the Expression of Interest Box at the Administrative Department against the issue of an acknowledgement by the Officer receiving the application.

Applications should not be sent by electronic means, by Post or by fax.

Incomplete, inadequate or inaccurate filling of the application form may cause elimination from the Expression of Interest exercise.

Applications not made on the prescribed form bearing the seal of the District Council of Riviere du Rempart will be rejected.

The Closing date for submission of applications is **Friday 26 Dec 2025** by 15.30hrs at latest.

Applications received after the prescribed date and time will not be considered.

The successful applicant/s will be required to sign a contract governing the terms and conditions in respect of the occupation of stall.

The successful applicant will be required to produce all documents listed at time of signature of contract.

Upon the signature of contract, the successful applicant/s will have to pay the monthly right of occupation.

The Council reserves the right to cancel at any time the whole Expression of Interest Exercise, without hereby incurring any liability whatsoever to those persons who have expressed an interest or to any of the successful applicant and this without the necessity to give any reason whatsoever.
